NLGYC Membership Category/Type Definitions and Rules

General: All memberships include: Bulletin mailing, maintenance of capital investment, the right to visit the property by land or water and the attendance at the Annual Membership Meeting.

Active Membership Categories:

Season with facilities Includes use of the tennis courts, parking lot and launching facilities for racing class sailboats, participation in racing and day-use of moorings, attendance at all club events and voting.

Season Includes attendance at all club events and voting. Also includes the use of the dock and parking lot while attending events and meetings

Short Season The equivalent of Season with Facility Membership, but it is limited to two consecutive or separate weeks in the increments of one week, including the surrounding weekends.

Limited Membership categories:

Associate Attendance at two Events and use of Facilities twice.

Corresponding No attendance at Events or use of Facilities.

Events are organized activities at the club not involving use of facilities (except parking in lot or at dock) e.g. social events.

Facilities include the tennis courts, parking and launching for racing class sailboats, participation in racing and day-use of moorings.

Membership types:

Family Parent, parents or legal guardians with active children under 25 years of age.*

Couple Couple without Active children under 25 years of age.*

Individual Person without Active spouse or Active children under 25 years of age.*

* Children under three, or under, do not require move to Family membership

Other Membership Rules:

- Guest Privileges: A member may have a guest use the club in accordance with that member's privileges on two
 occasions. Any guest should not be offered these privileges more than twice in a season. Guests must be
 accompanied at all times by their sponsoring member. NLGYC members may not be offered guest privileges. To
 encourage and support sailing participation, guest limitations do not apply to crews while they are participating in
 racing activities.
- 2. Extended Family: Individuals under the age of 25 will be granted membership privileges consistent with the highest activity level of member ancestors living in the same household, including relief of surcharge payments in the Junior Program fees.
- 3. A child of an ACTIVE FAMILY member may apply for his or her own membership, exempt from the Capital Assessment, as early as the summer in which he or she achieves age 21, provided that the family has maintained ACTIVE FAMILY membership for the five years leading up to the year in which the application of the child is submitted. This privilege, and the five year prior membership requirement, remain in effect until the summer in which the child achieves age 25. If the child does not become a member by the summer he/she achieves age 25, such individual will no longer be considered part of that family's membership, and if later applying for membership, will be required to pay the full capital assessment for new members.
